**Rosann Damelio**

Rosann most recently was Office Coordinator for FHS/MOG during the period when the organization was hindered by overlapping issues: Covid and no Executive Director. During this challenging time, she gained a clear appreciation of what it takes for this small non-profit to succeed, both at the level of mission/vision and in the many details of day-to-day activities. She wants to enhance community awareness and public visibility to create new members and volunteers. Rosann's eclectic working career has given her a variety of relevant experiences, especially in the importance of relationships. Although trained as a dental hygienist (Forsyth), she soon moved to TJX Corporation assuming various roles, ending with Client Relationship Manager. A lifetime learner, she has Certificates in Business Analyst and Project Management. After years of visiting Falmouth she and her family bought property here in the early 2000s, and moving to year-around status five years ago. Rosann became a Massachusetts licensed real estate agent, practicing in the Upper Cape area. Her current position is at Cape Cod Healthcare as Manager of Donor Sponsorships. She will be new to the FHS Board, up for election to a three-year term.

**Michael Kasparian**

Michael served on the FHS Board before the addition of the Cultural Center and renovation of Conant House; he is looking forward to being part of the restoration of Wicks House (in his words: "our finest asset") and strengthening our collections. He has a lifelong interest in American furniture, decorative arts and architecture from the Colonial and Federal periods. He has a Certificate in Arts & Antique Appraisal from the Rhode Island School of Design, and works as a personal property appraiser focusing on arts and antiques. His formal degrees are from Rhode Island College (BA) and Bryant College (MBA). He and his family have been residents of Falmouth since 2005. In addition to being a Town Meeting Member, he serves on several non-profit advisory boards. His current position as President of the Falmouth Chamber of Commerce has put him in touch with businesses, non-profits and individuals across our community. Up for new three-year term.

**Rocco Maffei**

Rocco's career began with serving 5 years as active duty with United States Air Force and 30 years in the USAF Reserves, retiring in 2005 as a Colonel. With degrees from Trinity College (BA) and University of Maine Law School (JD), he pursued a legal career in corporate positions. When he retired in 2011, he began volunteering at the Museums, working in almost every possible capacity: school docent, house docent, prior Board member including past President and participant in events as disparate as Night Watchman, Katharine Lee Bates Poetry Fest, readings for July 4<sup>th</sup> and Teddy Bear Picnic. He spearheaded a 2015 dinner honoring 25 WWII Falmouth veterans. Rocco enjoys interacting with the public while telling the stories of Falmouth. Other local non-profits that he has volunteered for are Old Stone Dock and Friends of Nobska Light. Rejoined FHS Board, August 2022, up for full three-year term.

**Carolyn Partan**

Carolyn retired in 1999 from working as a real estate attorney in Boston and has been an active volunteer for FHS ever since. Like many others, she has taken on multiple roles. She revived and expanded the third grade program plus participated in other school collaborations. She has worked on fundraising, including as co-chair of the 2016 renovations of Conant House. Other positions she has held include Interim Executive Director (2000-2001), Secretary of the Board (2000-2006) and most recently as President (June 2022 –

present). She has done extensive research on Falmouth's whaling history, among other topics. For the new Falmouth Art Center, Carolyn was a key person in its building and fundraising. Prior to moving year-around to Falmouth, she served on the Massport Board by gubernatorial appointment. Wellesley College (BA) and NYU School of Law (JD). Rejoined Board May 2022, will serve one more year, if elected.

### **Robert Ripley, Jr.**

Bob has retired from a career as a senior bank and wealth management executive with extensive banking, finance, audit, investment and strategic planning experience. He started his career in banking at Shawmut Bank and in 1991 founded Trust Tax Services Of America, acquired by SunGard in 2003. Among his past positions are President, Merchants Trust Company; Vice President, State Street Bank; and Executive Vice President, Martha's Vineyard Savings Bank. His love of local and American history has drawn him to work with a number of historic institutions. His current job is for the Concord Museum as Director of Finance and Operations. As a volunteer, he serves on the Massachusetts Historical Society Board as Trustee and Chair of its Collections and of the Audit Committees. He has been a resident of Falmouth since 2008. In that time, he has been chair of the Town of Falmouth's Finance Committee and of the Falmouth Public Library Support Fund. He also was previously on the FHS Board. In the past year, he served on the Search Committee for our new Executive Director. He has degrees from Bentley (BS, accounting) (also now chair of its Legacy Society), Bryant University (MST), and Nichols College (MBA). His desire to serve his community and support our new Executive Director has led him to volunteer again for the FHS Board. Up for new three-year term.

### **John Shemo**

John has extensive experience as a Board member and leader of a wide variety of non-profits, mostly in the Hartford, CT area. For 18 years he served on staff as Vice President and Director of Economic Development for the MetroHartford Alliance. For the last three years of that time, VP of Entrepreneurial Ecosystems was added to his portfolio. Significant among his volunteer activities were with the Northeastern Developers Association and the Rotary Club of East Hartford; for both organizations, he served as President. He and his wife Deb (a former FHS staff person) became Falmouth property owners in 2008 and year-around residents in 2016. In Falmouth John has volunteered with VIPS (Volunteers in Public Schools), teaching an entrepreneurship program to 4<sup>th</sup> graders. John's formal education is with University of Connecticut (BA) and University of Hartford (Master of Public Administration). Will be new to FHS Board, three-year term.

Originally trained as a professional dancer, she has been a physical therapist for the past 32 years, for much of that time and currently with Cape Cod Healthcare. Specializing in geriatric rehabilitation, she interacts with the community on a daily basis. Over the years, she has been an active participant in a variety of roles in the performing arts in Falmouth. Falmouth Theatre Guild, Dancer's Studio and her own dance company, Summer Dance Theatre are just some of the organizations she has worked with. A past member of the Vestry for Church of the Messiah, she took a leadership role in the preservation, and related fundraising, for the Woods Hole cemeteries. Eckerd College (BA), New York University (MFA in dance) and Boston University (MS in Physical Therapy). Will be new to FHS Board, three-year term.

All of these factors combine to give him useful perspectives for a Board member of the Historical Society. For FHS/MOG, she has been a walking guide for a number of years and more recently joined the Collections Committee. Ann has completed one three-year term as a FHS Board member and is up for re-election for a second three-year term.
